

Policy for applicants and students under the age of 18 under-18s) of Lancaster University Leipzig

Introduction

Lancaster University Leipzig (University) treats all students as independent, mature individuals regardless of their entry age. Lancaster University Leipzig also accepts applicants who have not yet reached the age of 18 and are therefore minors (underage). Special regulations apply to individuals who are under 18; in particular, these students require the consent of legal representative(s) (usually the parent[s]) to exercise certain rights and obligations as members of the University.

A prerequisite for admission to the Lancaster University Leipzig is that the legal representative(s) (usually the parent[s]) and the applicant approve this policy and sign the attached <u>General Consent</u> and send it to Lancaster University Leipzig.

No parental Responsibilities by Lancaster University Leipzig

The legal representative(s) acknowledge(s) that the obligation to supervise underage students (Aufsichtspflicht) is not the responsibility of Lancaster University Leipzig, its members or other related persons or representatives, but of the legal representative(s) of the underage student. Lancaster University Leipzig will not assume any rights, obligations or powers that the legal representative(s) have in relation to an individual who is underage and will not act in loco parentis (act with and assuming the responsibility of the legal representative(s)) in relation to underage students.

Entering into a Contract

For a declaration of intent as a result of which he/she does not receive only a legal benefit (lediglich rechtlicher Vorteil), a minor applicant requires the consent of his/her legal representative(s). Therefore, the legal representative(s) must sign the attached General Consent before a student contract shall be entered into with Lancaster University Leipzig.

Obligations of the Legal Representative[s]

The legal representative(s) undertake(s) to fulfil all obligations arising from contracts concluded between Lancaster University Leipzig and the applicant (e.g. payment of tuition fees, etc.).

Excursions and Off-Site Activities

Courses at Lancaster University Leipzig can include mandatory and/or optional excursions or other activities outside the University. Lancaster University Leipzig cannot assume any additional responsibility, in particular no supervisory duties for such excursions or activities for an underage student other than the general duty of care responsibilities as for students over the age of 18. The legal representative(s) of the underage student, by signing the attached General Consent, grant(s) consent to the underage student's participation in the aforementioned excursions and activities.

Provision of IT services

Lancaster University Leipzig provides email services and internet access to all students. These services are provided and used unsupervised. Students are expected to act in an adult and responsible manner when using these services and to abide by the Computer User Agreement of Lancaster University Leipzig.

Child Protection

Lancaster University Leipzig takes the protection of under-18s very seriously. As far as possible, the University endeavours to comply with all regulations relating to the protection of underage persons, in particular in relation to tobacco and alcohol consumption and to unaccompanied minors out in public after the legally permitted time (please find a summary of the Youth Protection Legislation (Jugendschutzgesetz) attached). However, the University will not supervise students in these or other matters outside of University premises or official University activities.

Lancaster University Leipzig does not have any personnel or technical measures in place regarding students accessing unsuitable or illegal materials (e.g. supervision or use of software for filtering pornographic or criminally relevant content from the internet) in the course of making use of the free internet access. Additionally, materials rated as unsuitable for people under the age of 18 may occasionally be used for academic purposes.
